

## Privacy Policy

This Privacy Policy describes how we collect, use, disclose, and protect your information when you visit or interact with **lemonadestandamenities.com** (the “Site”). By using the Site, you agree to the practices described in this Policy.

### 1. Information We Collect

#### Information You Provide

We collect personal information you voluntarily provide, such as when you:

#### Information Collected Automatically

When you visit the Site, we may automatically collect:

- IP address
- Browser type and device information

This information is collected through standard server logs, cookies, and similar technologies.

### 2. Cookies and Tracking Technologies

We use cookies and similar technologies to:

- Operate and improve the Site
- Understand usage and performance

- Remember preferences

You may control cookies through your browser settings. Disabling cookies may affect some functionality.

### **3. How We Use Information**

We use collected information to:

- Respond to inquiries and requests
- Operate, maintain, and improve the Site
- Send communications you request or consent to receive
- Monitor and analyze usage trends
- Protect against fraud, misuse, or security threats
- Comply with legal obligations

We do not sell personal information.

---

### **4. Sharing of Information**

We may share personal information with:

- **Service providers** (hosting, analytics, email, IT support) who assist in operating the Site
- **Legal or regulatory authorities** if required by law
- **Business successors** in the event of a merger, sale, or reorganization

All service providers are required to protect your information and use it only for authorized purposes.

### **5. Data Storage and Security**

Data is stored on secure servers operated by our hosting and service providers, primarily in the United States. Reasonable administrative, technical, and physical safeguards are used to protect personal information. However, no internet transmission is 100% secure.

## 6. Data Retention

We retain personal information only as long as necessary to:

- Fulfill the purposes described in this Policy
- Meet legal, accounting, or contractual obligations

You may request deletion of your information at any time, subject to applicable law.

## 7. Your Rights and Choices

Depending on your location, you may have the right to:

- Access your personal information
- Correct or update information
- Request deletion
- Object to or restrict certain processing
- Withdraw consent where applicable

## 8. Children's Privacy

The Site is not directed to children under the age of 16. We do not knowingly collect personal information from children. If we become aware that such information has been collected, we will delete it.

## 9. International Users

If you access the Site from outside the United States, your information may be transferred to and processed in the U.S. By using the Site, you consent to this transfer in accordance with applicable data protection laws.

## 10. California Privacy Rights (CCPA)

California residents have the right to:

- Request deletion of personal information
- Opt out of the sale of personal information (we do not sell personal data)
- Not be discriminated against for exercising privacy rights
